A complaint was received regarding a video appearing to show Simi Chacko campaigning to a lecture of UoN students, something which is prohibited and was communicated at the Candidate Briefings.

Appendix 1 shows both a screenshot from the video received as well as a transcript of that video.

Simi was contacted about the video and asked to confirm that it was them in the video. Simi responded by saying:

"I do want to inform you that I had a guest session with the current MSc International Marketing students today. This was, by all means, a student motivational talk which aims at interacting with students to inspire them for their future careers"

"I...have been specially invited by my tutor...to conduct this session which was solely dedicated to being an interactive session. In between the session, my tutor did mention that I am standing in for the Student elections 2021 as a candidate. By no means, I was pushing anyone to vote for me, but I did mention that if you find me eligible for the position, you may proceed with voting for me and the decision is all yours."

"So this was not meant to be any direct campaign ... I was invited to the session by the tutor"

Decision

Having reviewed the evidence the DRO feels that the following needs to be taken into account:

- There is clear evidence that Simi Chacko has spoken to a group of students which have gathered as part of course content.
- The transcript shows that there is a clear campaign message to the content of the video, and their was an attempt to canvass for votes.
- The session was organised by a University academic for the cohort of a specific course and would therefore by all reasonable assumptions be considered either a lecture or academic contact.
- The invite from the tutor to speak does not excuse the rule-break
- Any introduction from the tutor stating Simi was a candidate would not be reason for the speech then given by Simi which is against election rules.
- It can be assumed from the speech that a follow-up link was also sent to attendees.

Decision

There has been a clear breach of the "no campaigning in lectures or during academic contact" rule. As a result, the following sanctions will apply:

- Simi will be banned from all forms of campaigning for 48 hours, beginning at 00:00 on 20th February and ending at 23:59 on 21st February. This includes:
 - Face-to-face campaigning
 - Any new posts on social media
 - Responding to any queries regarding their campaign
 - Any other activity which may be reasonably considered campaigning activity.
- Simi is to be issued with a final written warning with regards her campaigning conduct.
